Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of 0.34% for the month, outperforming the benchmark by 0.22%. The top performing contributors to performance included Global Syndicated Loans, Bank Capital Securities and Global Hybrids; whilst the bottom performing contributors included Bond, Residential Mortgage Backed Securities (RMBS) and Asset Backed Securities (ABS).

Portfolio Asset Allocation

During the month, exposures to Cash, Investment Grade Corporate Credit and Global High Yield increased, whilst exposures to Basis Trades and Equity decreased. Current asset allocations are 3.4% in Global High Yield, 4.1% in Global Hybrids, 43.1% in Global Syndicated Loans, 13.3% in Capital Securities, 15.2% in Collateralised Loan Obligations, 0.5% in Investment Grade Corporate Credit, 3.4% in Residential Mortgage Backed Securities, 0.4% in Equity, 2.5% in Asset Backed Securities and 14.2% in Cash, Derivatives & Credit Hedged.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 15.2% in CLO, 9.0% in Banking and 6.2% in Insurance. The Fund's top three company exposures are: 2.0% in Allianz SE, 1.8% in Cybg Plc and 1.7% in Bank Of Ireland Group.

Leveraged Loan Market

The top performing leveraged loan industries in July were Consumer Durables, Forest Prod/Containers and Financial with returns (sector performance in USD terms) of 1.61%, 1.26% and 1.18% respectively. The worst performing loan industries were Energy, Consumer Non-Durables and Healthcare with returns of -0.04%, 0.43% and 0.58% respectively.

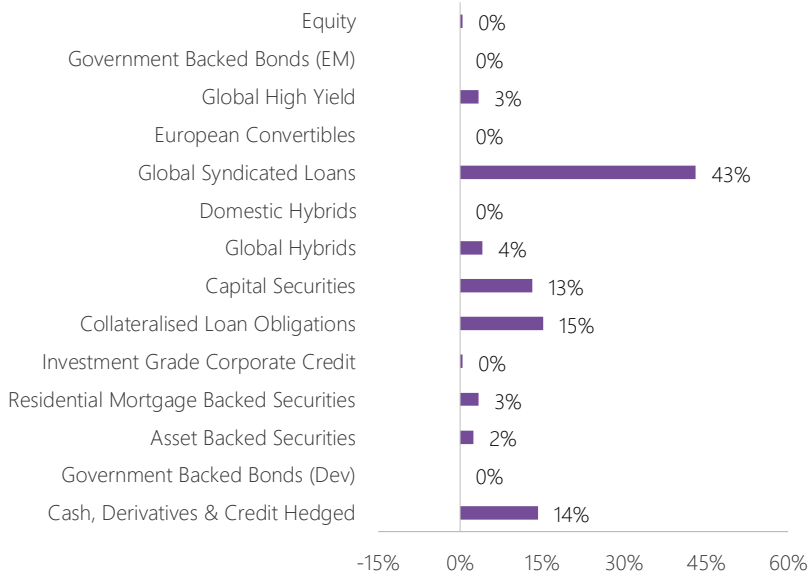
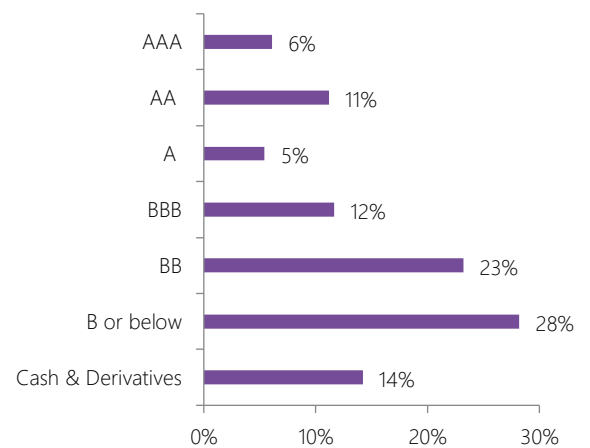
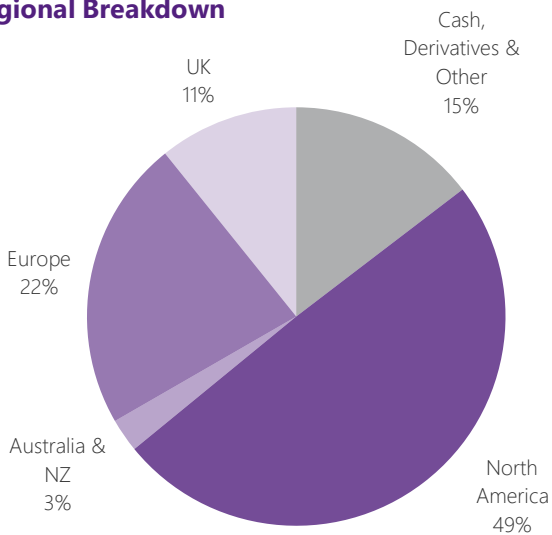
