

Monthly Commentary

The Longlead Pan-Asian Absolute Return Fund (the "Fund") generated a net return of +1.18% in the month of April. The month's performance was achieved on the back of varied conditions across the region's equity markets with markets such as Japan retracing while others such as Taiwan performed strongly. Profits were made from the long side in April with Taiwanese positions in particular benefiting from the rally while exposures in China and the US detracted. By sector, Consumer Discretionary, Materials and Information Technology positions contributed to performance, while losses were experienced in Financials and hedging positions.
