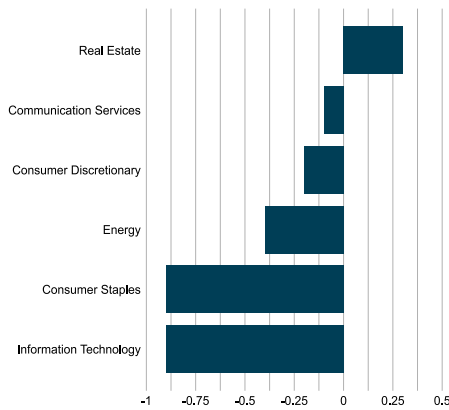

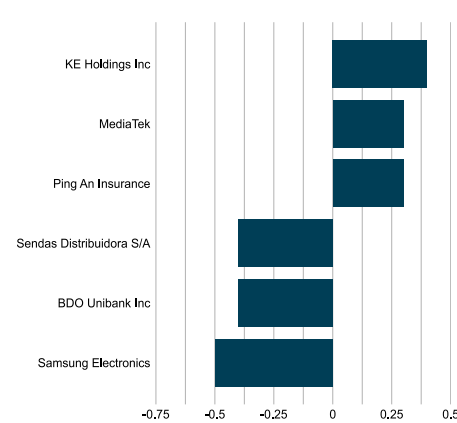

Fund features
